Resolved that the bill pass. Ordered that Mr. *Miles* and Mr. *Slason*, carry the same to the Council, and desire their concurrence thereto.

Message from the Council.

Mr. *Lockwood* delivered the Message.

"Mr. *Speaker*,--- "Council Chamber, 23d March, 1822.

"Ordered that Mr. *Lockwood* inform the House of Assembly, that the Council have agreed to the bill, to provide for opening and repairing Roads, &c. throughout the Province---and the bill, to appropriate a part of the Public Revenue for the services therein mentioned."

The House then adjourned for half an hour.

The House met pursuant to adjournment.

Mr. *Allen*, from the Committee appointed to present an humble Address to His Excellency, on the subject of the Bonds taken for Pine Timber cut on Crown Lands---reported that His Excellency was pleased to make the following reply :

"Notwithstanding I consider this Address as irregular, not having received the sanction of the Legislative Council, yet I shall, as requested by the House, transmit it to His Majesty's Ministers ; but at the same time, I shall consider it my duty to accompany it with my own observations, and those of His Majesty's Council, on the subject."

Message from His Excellency the Lieutenant-Governor, by *Xenophon Jouett*, Esquire, Gentleman Usher of the Black Rod.

"Mr. *Speaker*,

"His Excellency the Lieutenant-Governor, commands the attendance of this Honourable House, in the Council Chamber immediately."

The House of Assembly accordingly attended, and being returned, Mr. *Speaker* reported that he had addressed His Excellency, as follows :

"May it please your Excellency,

"The House of Assembly have made liberal grants for the Public Service. The Bills for those purposes they now tender for your Excellency's acceptance, praying your assent thereto. The House entertain the fullest confidence, that under your Excellency's judicious administration, those grants will prove beneficial to the interests of the Province."

And that His Excellency was pleased to give his assent to the following Bills, to wit :

An Act to encourage Inhabitants of this Province, who are engaged in prosecuting the Cod and Scale Fisheries, by granting Bounties on the same.

An Act to provide for and maintain an armed Cutter, for the protection of the Revenue of the Province.

An Act to provide for opening and repairing Roads and erecting Bridges throughout the Province

An Act to appropriate a part of the Public Revenue, for the services therein mentioned.

And that His Excellency was pleased to make the following Speech to both Houses :

"Gentlemen of the Assembly,

"Having communicated to you by Message, the Order of The KING in Council, disallowing two Acts passed in 1818, "which provided for the payment of the expenses of the Members of the Legislative Council and Assembly, with the reasons for such disallowance," and also my sentiments upon the
