Island Grove, Oct. 4.—Mr. Herbert J. Daly, president of the Home Bank, had another bad turn this morning, but is now resting comfortably, according to a report from The Elms, his summer home. Another nurse will arrive from Toronto tonight to assist in caring for the bank president. At one time during the night it was feared that he would not recover, but he has rallied sufficiently to inspire hope that if he is left undisturbed he will again be himself in several weeks. Mr. Daly, however, it is pointed out, has been ill for fully a year, and the bank crash simply accentuated his condition. On all sides, the admirable fortitude of Mrs. Daly is highly praised.

Canada's Minister of Railways Takes Part in Economic Conference.

Canadian Press Cable. London, Oct. 4 .- Turning again to he subject of trade development, the empire delegates met this morning for the second gathering of the economic conference. Hon. George P. Graham, minister of railways, represented Canada, Premier King being engaged in other work.

The conference in the first place liscussed the order on its agenda giving preliminary consideration to such subjects as co-operation in the collection of statistics on patents in the consular services. 'It is expected that empire settle-

ment will be the first important subject before the conference, although it is not likely to be reached today Great Britain's representatives, it understood, have expressed a desire that this subject should be taken up first among the important matters. Despite heavy appropriations, the overseas settlement scheme has met with the success which had been hoped for, while the unemployment problem is growing, not only in Great Britain but also all over the

whole of Ireland. Advices received today intimate that New South Wales is deferring her part in the immigration agreesay, secretary of the Western Ontario ment owing to the refusal of the land owners in that Australian state to subdivide their land for settlement

Wants Skilled Immigrants. Premier Smuts has plainly indi-cated that South Africa wants only! immigrants of the skilled artisan
