THE BROADCASTING

Power of the Commission

- 42 To furtherance of the telecommunications policy for Canada enounced in section 3 of the Act, the Commission may make regulations
- 41 (a) prescribing classes of broadcasting licences and general conditions applicable thereto
- 40 (b) with the approval of the Treasury Board, fixing the schedule of fees to be paid by licensees and providing for the payment of such fees, and
