a report that certain non-operating employees of the Canadian Pacific Railway Company in the Revelstoke area who were laid off as a result of the threatened strike have not been re-employed.

I referred the question to the railway company, and the management have advised me as follows. When the grain handlers strike became effective on the Vancouver waterfront on November 8, it was necessary to make a reduction of certain employees on the Revelstoke division because of a considerable reduction in traffic. The strike continued until November 30. In addition there has been a general decline in traffic in that area. Also, with the advent of winter conditions, toward the end of November track forces were reduced and one extra gang was laid off.

Up to the present time traffic conditions on the Revelstoke division have not warranted the return to the service of additional staff. It is expected that very soon the extra gang that was laid off will be returned to the service for handling snow and, if traffic picks up, other positions will be restored.

The management add that no reductions were made that could be classed as due to the proposed non-ops strike and in contravention of the act of parliament passed in connection therewith.

Mr. Hazen Argue (Assiniboia): May I ask a supplementary question. The minister's reply has to do with the grain handlers strike. My question had nothing to do with that; it had to do with the lay-offs which were made prior to the passage of Bill No. C-45. I wonder whether the minister would make further inquiries, since the information I have is to the effect that those employees were laid off in early December and not in November, which is the information he has been given.

Mr. Balcer: As I have explained, Mr. Speaker, the grain handlers strike was one of the reasons for the various lay-offs in that area. There were also other conditions that brought about the lay-offs. I think I have covered the question in my answer.

Mr. Argue: I should like to ask a further supplementary question. Does the minister feel that the C.P.R. management have given him a correct assessment of the situation, or are they giving the minister the run-around with an erroneous statement?

Mr. Speaker: Order. I doubt if it is an administrative responsibility of the minister to express an opinion on the C.P.R. management.
