**PUBLIC SERVICE****LEGISLATION TO INCREASE PENSIONS OF RETIRED CIVIL SERVANTS**

On the orders of the day:

**Hon. R. A. Bell (Carleton):** Mr. Speaker, may I ask the Prime Minister whether the government has completed its consideration of the unanimous report of the joint special committee of the Senate and the House of Commons on the public service for an increase in pensions of retired public servants and, if so, whether high priority will be given to implementing legislation?

**Hon. E. J. Benson (Minister of National Revenue and President of the Treasury Board):** Mr. Speaker, perhaps I could answer this question by simply stating that the government has not at this point completed its consideration of the matter.
