COLUMBIA RIVER-INQUIRY AS TO FEDERAL ASSISTANCE

On the orders of the day:

Mr. H. W. Herridge (Kootenay West): I wish to address a question to the honourable and gallant Minister of Industry. What cooperation from the federal government can the city of Trail and other communities on the Columbia river expect in combating the rapidly rising waters of the Columbia river?

An hon. Member: The High Arrow dam.

Hon. C. M. Drury (Minister of Industry): I thank the hon. member for having given me preliminary notice of this question. In reply to his very courteous inquiry may I say he is probably aware that the federal emergency measures organization is in constant touch with the flood situation in British Columbia, as well as with the provincial authorities. Under our present constitutional arrangements, requests for federal government assistance must originate with the provincial government.

I can assure the hon. member, however, that the federal government is fully aware of the danger of this situation and has mobilized the resources which it has available in order to meet any emergency which might arise, should a request be forthcoming from the provincial government.
