#### WITHDRAWAL OF CANADA FROM WORLD HOCKEY TOURNAMENT

### Hon. John C. Munro (Minister of National Health and Welfare): 1. No moneys have been paid to date.

2. At present consideration is being given to pay the out of pocket expenses incurred by: (a) Canadian Amateur Hockey Association, \$71,922; (b) Canadian Arena Company, Montreal, \$23,000; (c) Winnipeg Enterprises Corporation (This includes the re-payment to the province of Manitoba of \$25,962.09 which was a grant made to the Winnipeg Enterprises Corporation.) The Hockey Canada Corporation has agreed to pay these expenses and it is proposed the Federal Government reimburse Hockey Canada, \$78,305. No payments are being made for salaries for officials and hockey players resulting from the withdrawal of Canada from the World Championship.

### REGULATIONS REGARDING HEATING OF FEDERAL BUILDINGS

### Question No. 1,540-Mr. Skoberg:

- 1. Are here any regulations established by the Department of Supply and Services regarding coal and fuel oil for use in heating of federal government buildings and plants and, if so, what are these regulations?
- 2. Are there any regulations regarding the maximum percentage of sulfur content on coal and fuel oil purchases?

Hon. James Richardson (Minister of Supply and Services): 1. Yes. Coal and fuel oil for heating of Federal Government buildings and plants are bought in accordance with Canadian Government Specifications Board Standards. (Canadian Government Specifications Standards 3GP-2(d) d/31 Dec. 68; 18GP-2(d) d/24 Apr 62; 18GP-4(a) d/2 Sept 66; 18GP-5(a) d/2 Sept 66; 18GP-7 d/9 May 69; 18GP-8 d/10 Feb 67 and 18GP-3 d/24 Apr

2. These standards point out that the maximum level permitted of the sulphur content of the fuels is related to the particular heating plant design and local conditions. The accepted tenders require guaranteed sulphur contents to meet the requirements of the plant design and its location.
