mentally handicapped. We cannot, however, continue to shunt occupationally handicapped persons to employment outside the mainstream. The new programs must and will make provision for their employment in meaningful jobs in the private sector.

Mr. Atkey wanted to develop a co-ordinated employment strategy where the government would work in co-operation with the private sector. He said:

First, we intend to help to create an economic and social climate which will enable the private sector to prosper and take the initiatives which will lead to the creation of new permanent jobs. That is what my colleague, the Minister of Finance.

He was referring to the hon. member for St. John's West (Mr. Crosbie):

—has provided for in his budget. It is also an area where my department is taking some supporting initiatives and I will describe those in more detail shortly.

Secondly, we will encourage the private sector to play its full role in employing people whatever their sex, age, ethnic or cultural background. We will be doing this in complete realization of current and future social and demographic changes. Some examples are the increasing participation and rising expectations of women in the labour market, the aging of the baby boom generation, alterations in the family size and structure and the aspirations of native Canadians.
