CANADIAN WHEAT BOARD

REQUEST FOR ANNOUNCEMENT OF INITIAL GRAIN PRICES

Mr. Len Gustafson (Assiniboia): Mr. Speaker, my question is directed to the Minister of Transport. The Minister responsible for the Canadian Wheat Board, Senator Hazen Argue in the other place, has failed to announce to farmers the initial price of grain for the coming year. Farmers cannot stand the financial strain of falling grain prices, nor can farmers tolerate the Government playing politics with the important announcement of the initial price of grain. Will the Minister immediately announce the initial price of grain for the coming crop year so that farmers can plan their seeding operations?

Hon. Lloyd Axworthy (Minister of Transport): Mr. Speaker, it is my understanding that Senator Argue in the other place has already made a statement concerning the initial payments for grain. He indicated that he will be making that announcement before seeding begins so that farmers will have that initial advantage. I cannot give the Hon. Member the

specific date, but I believe the commitment of the Minister responsible for the Wheat Board will be fulfilled in a very short period of time.

REQUEST FOR IMMEDIATE ANNOUNCEMENT

Mr. Len Gustafson (Assiniboia): Mr. Speaker, the Hon. Senator in the other place has been making several announcements and several statements. What we are asking for is an announcement of the initial price of grain for farmers who are beginning their operations in the fields, and who need to know the direction for planting their crops in this coming year. Will he make an announcement immediately so that farmers can plan their planting operations?

Hon. Lloyd Axworthy (Minister of Transport): Mr. Speaker, I could only once again repeat my earlier answer. The other place is a useful, legitimate forum in which government policy is announced. The Minister responsible for the Wheat Board is a member of that particular Chamber. He will be making an announcement at the earliest possible date in order to allow farmers to undertake the advanced planning that is required. I will take notice of the Hon. Member's representations so that the Hon. Senator will be able to respond in a very short period of time.

PLIGHT OF LUBICON BAND IN ALBERTA

Mr. Jim Manly (Cowichan-Malahat-The Islands): Mr. Speaker, my question is for the Prime Minister. Last Fall Doctor Anwar Barkat of the World Council of Churches' Program to Combat Racism wrote to the Prime Minister concerning the Lubicon Lake Indian band in northern Alberta. He wrote that the Alberta Government and multinational oil companies "have taken actions which could have genocidal consequences" for the band. After detailing these actions, he said that the Lubicon people "cannot be expected to survive as a people unless they receive immediate financial, political and legal help". Was the Prime Minister made aware of the contents of this letter? Did he answer it? What action did he take in response to this urgent plea for justice?

Right Hon. P. E. Trudeau (Prime Minister): Mr. Speaker, it escapes me at the time as to whether I have seen that letter, but I will take notice of the question and give the Hon. Member an answer.
