Petitions

Third, the Commission's claim that the reverse order of merit is applied when there are lay-offs is of concern, since guidelines do not exist for its application.

Finally, the problems of the division of responsibilities between the Commission and the Treasury Board Secretariat, first reported on in 1982 by the committee, should be resolved without further delay.
