Oral Ouestions

This is why we have introduced the observers program to prevent such situations. I am prepared to work closely with the fishermen to make sure that this kind of activities will not happen again in the future.

FINANCE COMMITTEE

Mr. Lorne Nystrom (Yorkton—Melville): Mr. Speaker, in the absence of the chairman of the finance committee my question is for the government House Leader.

I am not sure if the government House Leader is aware that on Monday and Tuesday of this week many people requested to be heard on the GST before the committee. The chairman's fax machine was working overtime.

I want to ask the government House leader this. In light of the offer by the chairman of the finance committee, and I quote: "I would be delighted to resign as chairman if that is necessary", can the government House leader now assure the House that the finance committee will be reactivated under a new chairman so that all of these Canadians and many thousands of others can be heard on this very important piece of tax legislation, the GST? Hon.
