Staff Relations Act (prohibition of strike and lockout in the Public Service).

The Acting Speaker (Mr. Paproski): Pursuant to Standing Order 68(2), the motion is deemed adopted.

Mr. Attewell: Mr. Speaker, the thrust of my private member's bill will be to preclude any future strikes by the civil service. This will be achieved by declaring all government services essential.

There are thousands of hard working, loyal civil servants, but many Canadians are fed up with the attitude of the more militant civil servants. Civil servants enjoy fully indexed pensions, good salaries and relatively secure jobs, but every few years they hijack Canadians by calling a strike thereby causing harm and anxiety to thousands of Canadians.

My bill would remedy this problem and I am pleased that my colleague, the hon. member for Mississauga South, is going to second my bill.

I think we want the principal players to know that other Parliaments around the world wish them success in this very historical conference. We hope that the outcome of this conference will bring long

lasting peace, security and safety for the peoples of all of those regions.
