

Mr. Bennett, a Member of the King's Privy Council, laid before the House, —Copy of a Pamphlet respecting the World Wheat Problem and the London Agreement regarding the same, dated January 5, 1933.

Mr. Bury, seconded by Mr. Smith (Cumberland), by leave of the House, introduced a Bill, No. 5, An Act to amend the Criminal Code (Appeal Part XV), which was read the first time, and ordered for a second reading at the next sitting of the House.

By Mr. Blair:—Order of the House for a Return showing:—

1. What sums were paid for legal fees, and for what services rendered to any Department of the Government since September, 1927, to the firm of Kilmer Irving and Davis of Toronto.
2. Who are now, or were the members of the firm during that time.
3. What other law firms of lawyers resident in Ontario have received fees from the Dominion Government, and in what amounts, since 1927.

By Mr. Veniot:—Order of the House for a copy of all correspondence, tenders and other documents, relating to a call for tenders for work on Shippegan Wharf, Gloucester County, New Brunswick.

By Mr. Veniot:—Order of the House for a copy of all applications, correspondence, and the report of the Civil Service Commission, relating to the appointment of sub-collector of Customs at the outport of Shippegan, Gloucester County, New Brunswick.

By Mr. Brasset:—Order of the House for a copy of pay lists and other documents, in connection with work done at Anse aux Canards River, Gaspé County, since August, 1930.

By Mr. Brasset:—Order of the House for a return showing a copy of all pay rolls and amounts of money disbursed, in connection with the work done by the Department of Public Works at Grande Entrée, Gaspé County, from July 30, 1930, to the present date.

By Mr. Brasset:—Order of the House for a return showing a copy of all pay rolls and accounts which have been paid by the Department of Public Works in the municipality of Hâvre aux Maisons, Iles de la Madeleine, from July 30, 1930, to the present date.

By Mr. Brasset:—Order of the House for a copy of all declarations, affidavits, telegrams and other correspondence, in connection with the dismissal of Grégoire Lafrance, of Pointe Basse, Iles de la Madeleine, as watchman of the light-house at l'Echourie, Iles de la Madeleine, and also relative to the appointment of his successor.
