and heartily commends the College to the sympathies, prayers and financial support of the people of our Church.

The motion was carried.

FINANCE REPORT, EASTERN SECTION.

The Assembly called for the Finance Report, Eastern Section, which was presented by Mr. J. C. MacKintosh, Chairman, who called attention to its leading features.

On motion, duly seconded, the report was received and adopted.

The Assembly called for the Report of the Finance Committee, Western Section, which, in the absence of the Chairman, was presented by Dr. Warden, who emphasized the fact that notwithstanding the special appeals made to the Church on behalf of the Century and Famine Funds, the ordinary funds had not in any way fallen off, and also called attention to the low relative cost of administering the funds of the Church, such cost being less than three and a-half per cent. He moved, seconded by Principal Caven, the reception and adoption of the report.

The motion was carried.

REPORT ON THE ROLL.

The Assembly called for the Report of the Committee appointed to examine the Roll of Assembly, which was given in and read by Mr. W. T. Wilkins, Convener, who moved its reception and the consideration of its recommendations. The motion was seconded and agreed to.

The recommendations of the report were, after amendment, adopted. The report is as follows:—

Returns have been received from fifty-five Presbyteries, giving the names of 305 ministers and 295 elders, appointed as Commissioners.

The name of Mr. Robert Murray is returned by the Presbyteries of Trinidad, Maitland, Superior, Victoria and Honan. He chooses to sit as a Commissioner from the Presbytery of Trinidad, and your Committee recommends that his name be removed from the list of Commissioners of the other Presbyteries above named.

Mr. J. A. Macdonald has been returned as a Commissioner from the Presbyteries of Westminster, Edmonton and Regina. He elects to represent the Presbytery of Westminster, and your Committee recommends that his name be removed from the Edmonton and Regina lists.

Mr. George Mitchell has been returned as a Commissioner from the Presbyteries of Brandon and Calgary. He chooses to represent the latter, and your Committee recommends that his name be removed from the Brandon list.

Mr. D. Morrice is a Commissioner from his own Presbytery, Montreal, and your Committee recommends that his name be removed from the lists forwarded by the Presbyteries of Kamloops and Kootensy.

The Rev. Professor Falconer, whose name as a minister is on the roll of Halifax Presbytery, has been chosen as a Clerical Commissioner by the Presbytery of Calgary. In the opinion of your Committee, he was not eligible for election by the Presbytery of Calgary, and the Committee recommends that his name be removed from the Calgary list.

Your Committee would suggest the desirability of more uniformity in the matter
