FORMER LONDONERS THREATENED.

Extraordinary Charges Made by Two Well-Known Vocalists.

A dispatch from Montreal says: A big sensation in church circles was caused today, when Mr. William J. Birks, organist of St. James' Methodist Church, entered suit against Mr. Herbert J. Patton, organist of Emanuel Church, for willful and malicious slainder, claiming the sum of \$2,500. In the same court Mr. John Marshall Williams, choir master and bass soloist of St. James' Church, entered suit against Mr. Patton, making the same charge and asking for the same amount. (Mr. Birks was formerly organist of Dundas Street Center Methodis Church, and Mr. Williams was a solo ist in the choir of the same church.) FORMER LONDONER

Rev. Dr. Scott, Methodist Missionary, Writes a Harrowing Letter About the Floods.

A private letter from Rev. Dr. Scott, of the Methodist College, Tokyo, Japan (formerly of this city), says that the poor people have suffered terribly from the floods.

"The water rose in the house of Rev. Wm. Elliott, our missionary at Toyama, to the height of five feet. Great numbers of poor people have been drowned. People who have been out fishing since the flood have hauled of the fate of their 14-year-old son, up dead body after dead body with their fishing hooks.

"On the day after our arrival two lady missionaries started for Kofu. Part of their road led through a mountain pass, where a stream runs. The road there was submerged, and those heroic ladies of our own Women's Missionary Society were obliged to walk one mile and a half through water well above the knee, while the current was so rapid that all strength they could command was needed to withstand its force."
