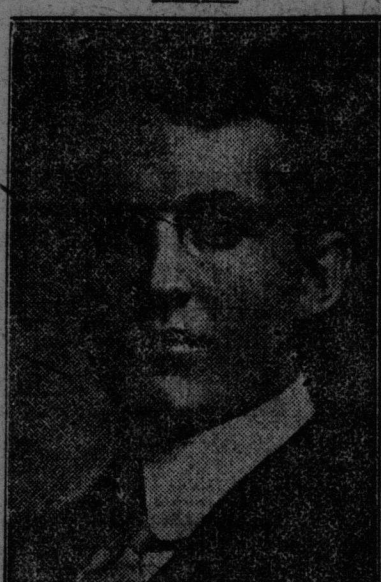

AMHERST'S ATTACK ON THE BOY PROBLEM

Citizens Believe it Cheaper to Form Than Reform—Social Question From Economic Standpoint

(Maritime Merchant)

In the industrial town of Amherst, N. S., an interesting experiment is being carried on under a committee of representative men in the way of a community-wide work for the boys of the town.

The success of this movement as a business proposition, is proving of great interest to people in all parts of the Dominion, while as a social movement it will be of notable value.

A secretary was employed who began work in August, 1911, and two months later, about 50 per cent of the budget for the year was made up of the school board which gave the number of boys and young men and a correct view of the field and needs.

A careful study of the school situation was then made and charts prepared showing the results obtained by the school system under present conditions.

It showed first, the need of a supervisor for the six schools, a man could give all the time necessary to visiting regularly all grades to see that the work done is up to the required standard.

Second, it brought out the fact that from non-attendance, irregularity and consequent failure at graduation time, the largely to the lack of careful supervision, and the non-enforcement of the truancy law, about 50 per cent of the budget for the last school year had been expended without result.

This has been met by the appointment of a man of wide experience as supervisor of the schools.

Again there was brought out the fact of the lack of co-operation between the home and the school and the ignorance on the part of most parents of the aims and ends of the school system.

This is being met by the formation of a Parents' Teachers' Association which meets monthly at the school buildings and at which practical and social programmes are bringing about a new understanding of the school situation.

To discover early physical defects and to give children a right physical start in life, medical inspection has been introduced into the schools and a trained nurse, graduate of one of the leading schools, is in charge of the physical inspection.

MORNING LOCALS

The members of Company A, 68th Regiment attended the performance of "Not Such a Fool as He Looks," in a body Saturday night.
