### Questions

2 Is the government aware of any such studies being made under the auspices of the United Nations?

3. What procedures, if any, have been incorporated for decontamination of returning space vehicles to protect the human and natural resources of the earth before further vehicles are sent into space?

Hon. Mitchell Sharp (Secretary of State for External Affairs): 1. No.

2. No. However, the U.N. Committee on the Peaceful Uses of Outer Space has taken note of such studies made by the Committee on Space Research (COSPAR) of the International Council of Scientific Unions (ICSU).

3. The United States National Aeronautics and Space Administration (NASA) has recently passed to the Canadian Embassy in Washington, as a matter of routine, a copy of NASA Press Release No. 69-83K of July 6 1969 which contains information on decontamination procedures for the return of Apolo 11 (pages 64-67 and 181-190). The United States Embassy in Ottawa has indicated it would be pleased to provide copies of these or other pages of special interest from the above release upon request.
