C.N.R.A.A.A. BEGINNING TO PROVE ITS WORTH

\$3,000 Grandstand Is Being Built on New Egerton Street Park.

Already the C. N. R. A. A. A. is beginning to prove its worth by way of providing a variety of sport and a modest figure for the employees connection with the C. N. R. in London and running out of London.

Monday, June 23, has been set as the date of the official opening of the association's new park on Egerton street, where the best of provision is rapidly being made for tennis (two courts), lawn bowling (several), croquet, and two softball diamonds. A grand stand is being erected, and accommodation for 2,500 persons. In connection with the grand stand, there will be ample dressing room, and shower bath accommodation. The stand is being built by the company and association on a fifty-five basis, the cost of it is estimated at about \$3,000.

On Monday of next week the first game will be played in the softball league. The entry of twenty teams for softball has necessitated two groups. Games will be played every night of the week, except Wednesday and Saturday nights.

The aim of those promoting the association is at least 800 members at a nominal fee of 25 per member. In former years the car shops were the only departments of the local railway fraternity organized for sports purposes. Now, under the head of the C. N. R. A. A. A., all departments are united and a splendid season's fun is being looked forward to by all the members of the association.

An added attraction in connection with the association, as at present constituted, is that the wife of an employee, if over 18, can secure full privileges upon the payment of the association fee of \$2.

The plan of uniting and marshaling the forces of all the departments for sport has been under discussion for two or three years past, but it is only this year that effect has been given to the scheme, which, thus far, promises to be a genuine success.

compensation presently offered, and the commission's eligible lists established as the result of examinations regularly held contain the names of large numbers of qualified candidates for positions in the postal service in practically every center in Canada.

Big Increase Involved.
In the course of the memorandum it is further stated that "the new schedules as proposed by the civil service commission involve an estimated reduction in the expenditure for such classes for 1924-25 of \$175,000 as compared with the existing rates of compensation plus last year's bonus; but that they are approximately \$222,000 in excess of such existing rates and reduced bonus of 1924-25.

"That the compensation schedules as proposed by the employees would involve an increase for 1924-25 of approximately \$1,921,000 over the existing salary rates plus the bonus as provided for 1924-25."

The memo proceeds: "The importance of this revision in the postal service will be apparent when it is considered that increases in basic rates of compensation and consequent increased cost of the service would not be confined to the postal service, but must necessarily be also applied to the whole public service as the work of salary revisions is proceeded with."

The memo states the officials of the postoffice department contemplate the following changes in working conditions:
Where payment for overtime now obtains it will, in future, be only allowed for duty exceeding 48 hours. Overtime will be liquidated by a convention by allowing time off within four weeks of the date when extra time was worked.

Estimated Costs.
Eight hours in ten schedule to be amended to eight hours in twelve. All employees must be examined to qualify for annual increases. Percentage on all annual sortation tests to be set at 90 per cent.

I. W. W. May Bomb Morgue

San Pedro, Cal., June 16.—Threats to blow up the morgue containing 43 victims of Thursday's explosion aboard the U. S. S. Mississippi, said by police to have been made by I. W. W. radicals, whose hall was raided and wrecked by sailors here Saturday night, caused a strong armed guard to be placed at the morgue to be thrown about the morgue early yesterday. The guard was placed as the result of information given to Police Lieutenant Hollowell to the effect that members of the Industrial Workers of the World planned to dynamite the morgue in retaliation for the attack on their meeting place.

CANCER GERM HAS BEEN ISOLATED

Dr. Glover Declares the Dread Disease Is Not Hereditary.

Butte, Mont., June 15.—Before a medical meeting held at St. James' Hospital Saturday night Dr. T. J. Glover, of New York, presented a paper describing in detail his cancer research work. He demonstrated by numerous slides his animal experimental work and showed and described the germ that, he said, causes cancer.

In his paper Dr. Glover said he has been able to isolate, in pure culture, a specific organism which when inoculated into healthy animals produced the disease.

Afterward, he said, he has been able to recover the organism again in pure culture from these animals. He also stated that he had been able to immunize healthy animals from cancer.

Dr. Glover declared his research work showed that cancer was not hereditary, that it seldom affected healthy epithelium, but was usually preceded by some form of irritation of low potency which breaks the resistance of the epithelial cells and permits infection.

ENTRANCE EXAMINATION BOARD MEETS TODAY
Over Fifty Per Cent Will Enter Secondary Schools Without Tests.

The entrance examination board met again today in the board of education rooms. Sessions will be held all this week to check up recommendations of primary school principals for grade eight pupils.

It has been estimated that between 40 and 45 per cent of the pupils of city schools will enter secondary school classes in September without having to write special entrance tests. It is for the purpose of establishing the number who have a sufficiently high standing on the year's work to pass in this way that the entrance board is meeting.

Those in class "B" who must write examinations, are not discouraged in any way. They have good chances to get through. However, through reason or examinations, those entering the year, they have not shown sufficiently high standing on the year's work.

There is also a class "C" of graduating of the entrance candidates. These are few in number, not more than one or two to a school. Class "C" pupils are those who have not been considered of sufficiently high standing to permit writing examinations.

LOSS ENORMOUS IN FOREST FIRES

The city solicitor has told the council that no money allocated for any work in the estimates could legally be taken for any other work no matter how necessary it might seem. So that the chances that the Quebec street sewer will be built this year are slim although the urgency of the work is recognized by the council.

VICTORY FOR MORRIS LOOMS IN HIS 101ST COURT CASE

Alleged "Green" Bones Cause Inspector To Hale Gootson Before Magistrate.

CONDUCTS OWN CASE

Case Remanded a Week and Inspector Advised To Pay Another Visit.

Although the result of the battle will not be known for a week, it looks as if Morris Gootson will emerge victor in his 101st legal skirmish in police court. The case was adjourned for a week by the magistrate who asked Inspector Sanders and Mr. Gootson to look over the matter "plant" at the foot of Matland street.

The whole affair arose over a quantity of alleged "green" bones in the Gootson yard on June 5 last. Mr. Sanders, health inspector for the city, claimed there was a pile of bones ten feet high in Gootson's yard on the day in question, and another batch were parked in boxes.

"Any odor?" asked the court. "Yes and I saw flies coming out of the bones," replied the inspector.

Mr. Gootson, who is known as the Hebrew lawyer, took his place at the counsel table and his attorney, Mr. Judd and J. G. Gillanders, and stated he wanted to case to go on as quickly as possible, as his time was valuable.

Springs to the Attack.
Mr. Gootson sprang to the attack once Mr. Sanders had finished his evidence, and cross-questioned the inspector closely, and in approved lawyer fashion, asked Gootson:

"You didn't try to find Gootson the day you were there?" thundered Morris. "Why did you come to my yard?"

"I can go into anyone's home, night or day," replied Mr. Sanders. "I suppose you can go there and get liquor out of Gootson."

"I don't drink," replied the inspector. "Were the bones near the dump?" "I could not say," replied Morris. "You couldn't say?" "I could say a great deal if I had to."

"Mr. Sanders, you don't know something," shouted Mr. Gootson. "If you had brought up a horse's hoof to the first joint I could tell you if they were bones or not," declared the inspector, when Morris showed him some nice clean bleached bones.
