While the majority of airport terminal buildings throughout Canada are operated by the Department of Transport, the air terminal building at Bagotville is operated by Air Canada and it is not the practice of that company to disclose the names of firms or persons submitting tenders, or information concerning

proposals received. Seven firms submitted bids.
