Inquiries of the Ministry

- 2. Viruses to be used as insecticides will have to be registered under the Pest Control Products Act and meet the requirements of the Food and Drugs Act insofar as acceptability is concerned. Fish, Wildlife and Forestry authorities will also be consulted in evaluating data to determine whether the insecticides should be accepted for registration under the Pest Control Products Act.
- 3. Precautions are those required under the Pest Control Products Act which include: (a) A full description of the insecticide including the chemical and/or biological properties of the active principle. (b) Evidence of effectiveness under field-use conditions. (c) Full description of the manufacturing process. (d) Assurance as to the safety of the product. (e) Approval of directions for, and conditions of use. (f) Any other measures which are deemed to be in the public interest to reduce risks.
- 4. Scientists in the Departments of Agriculture, National Health and Welfare, Indian Affairs and Northern Development and Fisheries and Forestry; United States Department of Agriculture and the World Health Organization. Also the Society of Invertebrate Pathology, the clearing house for information on insect pathogens used for insect control.
- 5. No. However, officials in departments having a responsibility for the control and use of insecticides are maintaining a watching brief on research papers and commercial developments both in Canada and in other countries.

STRAIT OF GEORGIA—ISSUANCE OF DRILLING PERMITS

Mr. T. C. Douglas (Nanaimo-Cowichan-The Islands): May I direct a question to the Prime Minister, Mr. Speaker. Has he received representations from the board of the regional district of Nanaimo and other interested bodies regarding proposed oil drilling in the Georgia Strait and the coastal waters of British Columbia? May I also ask whether any decision has been reached on whether such oil drilling permits will be granted by the government of Canada?

Right Hon. P. E. Trudeau (Prime Minister): I believe the question was whether I had
