#### TARIFF BOARD

TABLING OF REPORT ON FRACTIONS  
OF PETROLEUM

**Hon. Herb Gray (Minister without Portfolio):** Mr. Speaker, I wish to table today copies in English and in French of the report by the Tariff Board on Reference No. 141, together with a transcript of the evidence presented to the Board at its public hearings. The report covers fractions of petroleum for use as feedstocks in the manufacture of organic chemicals.

I would like to assure the House that the Tariff Board's recommendations will be carefully considered by the government. Therefore interested parties who wish to comment on this report should bring their comments to the attention of the Department of Finance as soon as possible.
