Mr. Doug Frith (Parliamentary Secretary to Minister of National Health and Welfare): Alcoholism (sic) and drug abuse are not notifiable diseases. No firm data exist from which to calculate a rate of incidence for whole populations, provinces or territories. A number of social indicators exist such as hospital admissions and hospital days for alcohol related illness, alcohol related deaths from accidents and violence, convictions for criminal offenses that are alcohol related, numbers of children taken into care for conditions that may be related to alcohol abuse etc. Many authorities talk of an incidence of alcohol addiction of 5 per cent in the general community and such estimates are often qualified and are regarded as conservative. Anecdotal accounts, observations by health personnel and other derivative opinion evidence suggests that the incidence of alcohol abuse is higher among Indian people than among non-Indians. One has to distinguish between alcohol addiction, which implies acquired tolerance and dependency, from simple alcohol abuse which implies inebriation and intoxication as availability and opportunity permit, but without true addiction.
