- 3. Was there pressure placed on public servants to participate even if they did not do so voluntarily?
- 4. Is the government willing to set up such fund-raising drives with Public Service participation for other universities and, if so, which universities?
- Mr. John Evans (Parliamentary Secretary to Deputy Prime Minister and Minister of Finance): I am informed by the Departments of Justice, Transport and Treasury Board as follows: 1. No. The Hon. Jean-Luc Pepin, Minister of Transport, with Mr. Charles M. (Skip) Armstrong, president, Canadian operations, Metropolitan Life Insurance Company, is serving as co-chairman for the University of Ottawa Achievement Fund campaign.

## TREASURY BOARD REGULATIONS—CHARITABLE CAMPAIGNS Question No. 1,356—Mr. Cossitt:

- 1. Does chapter 328 of the Treasury Board Regulations on charitable campaigns state in part that: "Other forms of government assistance such as use of cheque-stuffer services are hereby restricted to the United Way campaign . . . . "?
- 2. Were cheque-stuffers included with the June pay cheques of a large number of Public Service employees and, if so (a) what is the name and job designation of the most senior person in government authorizing such action (b) was the President of the Treasury Board aware of such action and, if so, on what date did he become aware and did he or any one acting on his behalf give permission for such action?
- 3. Was the President of the Treasury Board at any time contacted, directly or indirectly by, or on behalf of, the Minister of Transport on the subject of cheque-stuffers or any other aspects of the University of Ottawa's fund campaign and, if so, what are all the details and the dates involved?
- Hon. Donald J. Johnston (President of the Treasury Board): 1. Yes; however, Treasury Board can grant exemptions or extensions to the policy. Circular No. 1980-54 clarifies this flexibility by stating that additional assistance to organizations not associated with the United Way will be considered on a case-by-case basis, limited to the following alternatives:
  - (a) approval to distribute one campaign notice to public servants via the payroll distribution system; or
  - (b) similar to (a), but extended to identify public servants who are willing to work strictly as volunteers, who could answer inquiries and receive completed pledge cards or donations.

Over the past two decades, such assistance has been extended to the following institutions: University of Alberta, University of Calgary, University of Carleton, University of Guelph, University of Lethbridge, University of Ottawa, University of Windsor, the Children's Hospital of Eastern Ontario, The Ottawa Civic Hospital, CARE of Canada, The Canadian Cancer Society, The Canadian National Institute for the Blind.

- 2. Yes.
- (a) The President of the Treasury Board authorized the policy extension to cheque-stuffers for the University of Ottawa campaign.

- (b) Approval to distribute cheque-stuffers was given by the President of the Treasury Board in his letter of April 3, 1980, to the Hon. Jean-Luc Pepin, Minister of Transport, in his capacity as co-chairman of the University of Ottawa Achievement Fund campaign.
- 3. Mr. Pepin wrote to the President of the Treasury Board on March 7, 1980, advising of the campaign and seeking authority of the Treasury Board to bring the public service portion of the campaign to the attention of the public servants in the National Capital Area.
