### Oral Questions

Sport. In this morning's edition of *La Presse*, the Canada Sports Pool Corporation was described as a veritable nest of patronage reserved for members and friends of the Liberal Party of Canada. The article went on to give names and appointments in support of this allegation.

Given that, above all others, any national organization devoted to support Olympics, medical research, and amateur sport, should be free of such allegations, I want to give the Minister the first opportunity to deny categorically the allegations contained in that article. I ask him if he is in a position now to give the House, and the country, that categorical denial?

### [Translation]

Hon. Jacques Olivier (Minister of State (Fitness and Amateur Sport)): Mr. Speaker, I would like to point out to the Members of this House that the newspaper article in question, which says that friends of the Party in power were appointed to the Canada Sports Pool Corporation, does contain a modicum of truth,, but there are also some statements that are entirely wrong. Certainly, there were people who belonged to the Liberal Party, but there are also individuals who belong to the Progressive Conservative Party, and I cannot deny that either. What I can say is that belonging to a political party is not, and never will be, a requirement for appointment. In this area, the Canada Sports Pool Corporation was led by a concern for competence and success. The basic requirement as to select individuals who had been successful with Loto Canada, before the Progressive Conservative Government decided to abolish the Corporation and hand over \$500 million to the provinces, and that is strictly what happened.

Let me give an example. Notices were published across the country. In fact, the Opposition Critic mentioned that jobs were available with the Canada Sports Pool Corporation. There were 1,200 job applications across the country. We are still examining these applications and interviewing prospective candidates.
