May I seek the unanimous consent of the House for this proposal?

BUSINESS OF THE HOUSE

I think it is also fair for me to indicate, with respect to Bill C-4 and Bill C-6, that notwithstanding the fact that the second reading motion involves reference to the standing committees of this House, there will be a disposition on the part of all Parties to have those Bills dealt with at all stages on the floor of the House.
