TOBACCO PRODUCTS CONTROL ACT

MEASURE TO ENACT

The House proceeded to the consideration of Bill C-51, an Act to prohibit the advertising and promotion and respecting the labelling and monitoring of tobacco products, as reported (with amendments) from a legislative committee.

The Acting Speaker (Mr. Paproski): There are 19 motions in amendment on the Order Paper to amend Bill C-51, an Act to prohibit the advertising and promotion and respecting the labelling and monitoring of tobacco products. After deliberation, I am now ready to make a ruling with respect to their acceptability. All of these motions I find are in order.

Motions Nos. 1, 2, 3, 4, 5 and 6 all deal with advertising and will be grouped for debate and voted on as follows. If Motion No. 1 is carried, the question will not be put on Motion No. 2. A negative vote on Motion No. 1 necessitates a vote on Motion No. 2. An affirmative vote on Motion No. 2 will obviate the necessity of a vote on Motions Nos. 3 and 4. Motions Nos. 5 and 6 will be voted on separately.

Motions Nos. 7, 8, 9, 11 and 12 all deal with promotion and sponsorship. They will be grouped for debate and voted on as follows. An affirmative vote on Motion No. 7 will obviate the necessity of a vote on Motions Nos. 8 and 9. A negative vote on Motion No. 7 necessitates a vote on Motion No. 8. An affirmative vote on Motion No. 8 will obviate the necessity of a vote on Motion No. 9. A negative vote on Motion No. 8 necessitates a vote on Motion No. 9. Motions Nos. 11 and 12 will be voted on separately.

Motion No. 10 standing in the name of the Hon. Member for Vancouver East (Ms. Mitchell) is virtually the same as an amendment which was moved, debated and negatived in committee. Therefore in accordance with Standing Order 114(10), it will not be selected for debate in the House.

Motions Nos. 13, 14, 15 and 16 deal with reports, regulations, offences and punishments. They will be grouped for debate but voted on separately.

Motions Nos. 17, 18 and 19 dealing with the coming into force of the Bill, will be grouped for debate but voted on as follows. An affirmative vote on Motion No. 17 will obviate the necessity of a vote on Motion No. 18. A negative vote on Motion No. 17 necessitates a vote on Motion No. 18. Motion No. 19 will be voted on separately.

I will now propose Motions Nos. 1, 2, 3, 4, 5 and 6 to the House for debate.
