The said Bill was then read a third time accordingly.

The question was put whether this Bill shall pass?

It was resolved in the affirmative.

Ordered, That the Clerk do go down to the House of Commons, and acquaint that House that the Senate have passed this Bill without any amendment.

The House, according to Order, was adjourned during pleasure, and again put into a Committee of the Whole on the Bill intituled : "An Act further to amend, and to " consolidate as so amended, the several Acts respecting the Public Lands of the " Dominion therein mentioned."

(In the Committee.)

The Second to the Nineteenth clauses inclusive, read and agreed to.

Twentieth clause read and amended as follows:-

Page 8, line 46.-Leave out from "provided" to "all." Twenty-first to Twenty-third clauses inclusive, read and agreed to.

Twenty-fourth clause read and amended as follows :---

Page 10, line 36 .- After "council" leave out "purchase" and insert "sales."

Twenty-fifth to Thirtieth clauses inclusive, read and agreed to.

The Thirty first clause being read, it was moved to add the following as sub-

"4. Provided also that the bond fide cultivation of five acres of such land by the section 4 :--"person who has obtained a homestead entry therefor, shall be accepted as an " equivalent for the term of residence hereby required during the first year after " entry."

The question of concurrence being put thereon, the same was resolved in the

negative, and The said Thirty-first clause was again read and agreed to.

The Thirty-second clause read and agreed to.

The Thirty-third clause read and amended as follows :---

Page 15, line 31.-After "has" insert "heretofore," and after "obtained" insert "or hereafter obtained."

The Thirty-fourth to the Thirty-seventh clau es inclusive, read and agreed to. The Thirty-eighth clause read and amended as follows :----

Page 16, line 44.-After "providing" insert "horses, cattle." The Thirty-ninth to the forty-first clauses inclusive, read and agreed to.

The Forty second clause read and amended as follows :---

Page 18, line 25.-Leave out from "behalf" to the end of the clause.

The Forty-third to the Eightieth clauses inclusive, read and agreed to.

The Eighty-first clause read and amended as follows :-

Page 31, line 38.-Leave out from "stead" to the end of the clause, and insert

"2. Every order or regulation made by the Governor in Council, in virtue of the following words :-"the provisions of this clause, or of any other clause of this Act, shall, unless other-"wise specially provided in this Act, have force and effect only after the same has "been published for four successive weeks in the Canada Gazeite; and all such "orders or regulations shall be laid before both Houses of Parliament within "the first fifteen days of the Session next after the date thereof."

The Eighty-second clause read and agreed to.

The Eighty-third clause read and amended as follows :---

Page 31, line 14 .- After " before " insert " them or."

Page 31, line 45.—After "by " insert " them or."

Page 31, line 47.-After "before" insert "them or."

Eighty fourth to the One hundreth and twenty-sixth clauses inclusive, read and

Schedules A, B, C, D, E, F, G, H, I, J, K, L, M, N, O, and P, read and agreed to. agreed to. The Title again read and agreed to,
