OVER A HUNDRED WITNESSES

Will Be Called in the \$150,000 Libel Suit of Mrs. Woodbury v. Mrs. Eddy.

EDITOR HANNA ON THE STAND.

The Point at Issue is as to Whether Malice Was Intended in the Article.

Boston, June 4.—With the 100 or more witnesses who have been summoned in connection with the trial of the \$150,000 libel suit of Mrs. Woodbury v. Mrs. Eddy, the matter will be brought to the Superior Court room, the space left for spectators is meagre, and this morning, as on previous days, it was far too small for the crowd that wanted to get in.

The first question by Mrs. Woodbury's counsel was: "Have you the original of the message sent by Mrs. Eddy to The Christian Science Journal in May, 1897?"

"I have a copy of The Journal containing the message," was the answer.

The question of Malice.

Counsel offered the publication referred to as evidence, saying that Mrs. Eddy's reference to Mrs. Woodbury as being unfriendly to Christian Science showed malice.

The evidence was admitted subject to exception, simply on the question of malice.

Judge Hanna admitted that the message was published after Mrs. Eddy had refused the request of the witness to reply to an article in a magazine by Mrs. Woodbury, attacking Christian Science.

The article by Mrs. Woodbury, which previously had been offered as evidence, was presented again and excluded, the court holding that it was not relevant.

Mrs. Eddy had read the article. Later the court ruled out the bylaws of the Christian Science Church as not having any connection with the present suit. Exception was taken by plaintiff.

The witness admitted that as an employee of the Christian Science Publishing Society the amount of her salary was determined by the Board of Trustees. The deed of trust given by Mrs. Eddy to the trustees of the Christian Science Publishing Society, which was offered as evidence, was excluded.
