URGES UNITED STATES
TO ASSIST IRELAND

Lord Mayor O'Callaghan Com-
pletes Testimony At
Washington.

WASHINGTON, Jan. 14.—Daniel J.
O'Callaghan, Lord Mayor of Cork, who
reached the United States last week as
a stowaway and without a passport,
completed his testimony this afternoon
before the "Committee of One Hun-
dred" investigating Irish conditions,
and thereby accomplished the an-
nounced purpose of his visit to the
United States.

In completing his testimony, which
was filled with wild charges against
the British authorities, O'Callaghan
presented a fervid appeal for support
of the Sinn Féin cause. With this ap-
pel he coupled the declaration that
the United States and Great Britain
alike entered the war pledged to the
principle of self-determination for
small nations. He declared that Britain
had shown in her treatment of Ireland
that she did not show more interest in
Irish than in any case. "We will
continue the fight," he said.

YOUTH PLAMES
TIME IN CELLS
FOR HIS CRIME

Farm Boy Who Held Up Wo-
man Is Sent To Burwash.

GODERICH, Jan. 14.—Wilfred Al-
bright, aged 20, who held up Mrs. A.
Lynch and stole some money, a rifle
and 75 rounds of ammunition, appeared
before Judge Dickinson today and pleaded
guilty to the robbery. He attributed
his start on a criminal career to read-
ing dime novels.

Judge Dickinson addressed the prisoner
at some length, stating that Albright
had served a term at the industrial
school for thieving and that it was hard
punishment to give him in order that
he might come out and start life over
again in the right path that would
make a man of him. The judge sen-
tenced Albright to the Burwash Farm
for at least six months and not more
than two years, less one day.

HELD FOR SHOOTING.

Thursday night and waived extradition.
