inspector February 1, 1964; inspector February 1, 1966; superintendent August 1, 1970.

GOULETTE Reg. No. 10790 (S/10657), ex-Sgt. Ralph James Goulette, 90, died March 28, 1997, at Arnprior, Ont. He was born April 2, 1906, at Charlo Station, N.B., and joined the Force April 19, 1930, at Ottawa. Upon completion of training at "N" Division, Goulette was posted to "C" Division, Que., namely at Montréal, Quebec City, Bersimis, Sept-Îles, Rivière-du-Loup, Rock Island, Amos and Rouyn, and then retired May 31, 1949. He was promoted to lance-corporal September 1, 1939; corporal April 1, 1941; sergeant November 1, 1944. He subsequently reengaged as a special constable October 18-31, 1952.

Goulette was awarded two Commissioner's Commendations: the first in August 1939, for his resourcefulness in saving a seven-year-old child from the waters at Sept-Îles; the other in September 1940, for good work and assistance to the Quebec Police Force in the successful arrest of a suspect. He had also worked for two years with the New Brunswick Provincial Police, namely at Buctouche *circa* 1930, before joining the RCMP.

GRANT Reg. No. 10899, ex-Cst. John Richardson Grant, 87, died February 10, 1997, at Cardston, Alta. He was born April 3, 1909, at Glasgow, Scotland, and joined the Force February 9, 1931, at Lethbridge, Alta. Upon completion of Part I Training at "Depot" Division, Grant was posted to "E" Division, B.C., namely at Vancouver, then after Part II Training at "N" Division, he was posted to "H" Division, N.S., where he worked at Halifax. Grant was subsequently transferred to "J" Division, N.B., where he served at Saint John, Perth, Minto and Fredericton and then to "A" Division, at Ottawa, taking his discharge February 8, 1941.

Grant subsequently served as Chief Constable for the towns of Bow Island and Slave Lake, Alberta.

HANSON Reg. No. 26416, ex-Cst. Alden Harry Hansen, 52, died July 4, 1997, at Saskatoon, Sask., where he was born May 1, 1945, and joined the Force March 14, 1968. Upon completion of training at "Depot" and "P" Divisions, Hanson was posted to "E" Division, B.C., namely at Cranbrook, Vancouver and Fernie, taking his discharge April 21, 1975. Hanson reengaged into the Force on March 13, 1978, at Saskatoon, and was posted to "F" Division, Sask., namely at Yorkton, Kerrobert and Foam Lake, and then retired on January 20, 1996.

HARROLD Reg. No. 29199, ex-Cpl. Edward Allan Harrold, 47, died April 6, 1997, at Gillies Bay, B.C. He was born February 7, 1950, at Ladysmith, and joined the Force August 16, 1971, at Victoria. Upon completion of training at "Depot" Division, Harrold was posted to "K" Division, Alta, namely at Leduc, Sherwood Park, Edmonton, St. Albert, Assumption, Lake Louise and High Prairie. He was subsequently transferred to the following locations: in April 1983, to "G"

Division, N.W.T., at Fort Resolution and Yellowknife; on October 1, 1992, to "E" Division, B.C., at Quesnel and Texada Island, and then retired on August 28, 1996. Harrold was promoted to corporal June 28, 1982.

HATCH Reg. No. 19493, ex-Sgt. William Wilfred Hatch, 60, died May 28, 1997, at Edmonton, Alta. He was born February 12, 1937, at Yorkton, Sask., and joined the Force June 18, 1956, at Regina. Upon completion of training at "Depot" and "N" Divisions, Hatch was posted to "K" Division, Alta, where he served at Lethbridge, Red Deer and Edmonton, and then retired March 15, 1975. He was promoted to corporal November 1, 1967; sergeant July 1, 1973.

HOLLINGWORTH Reg. No. 18432, ex-S/Sgt. Vincent James Hollingworth, 69, died May 23, 1997, at Westbank, B.C. He was born December 29, 1927, at Montréal, where he joined the Force November 9, 1953. Upon completion of training at "Depot" Division, Hollingworth was posted to "E" Division, B.C., where he worked at Prince Rupert, Burns Lake, Kitimat, Cloverdale, Vancouver, North Vancouver, Fort St-John, Fort Nelson, Penticton and Kelowna, and then retired on May 22, 1987. He was promoted to corporal August 1, 1966; sergeant July 1, 1972; staff sergeant July 1, 1976.

Hollingworth was awarded the Commissioner's Commendation for leadership in the safe evacuation of civilians and the subsequent arrest of an armed and emotionally disturbed man who had killed one person and wounded another on December 24, 1972.

JOHANNSON Reg. No. 14491, ex-Sgt. Bjorn Laurence Johannson, 75, died April 30, 1997, at Burnaby, B.C. He was born September 28, 1921, at Elfros, Sask., and joined the Force as a special constable at Vancouver, April 18, 1942. Johannson took his discharge on April 17, 1945, to join the BCPP where he served at Vancouver, Esquimalt and Grand Forks. He reengaged into the RCMP when the two forces amalgamated on August 15, 1950 and was posted to "E" Division, B.C., namely at Burnaby, North Vancouver and Fairmont Training Academy, and then retired on May 27, 1966. Johannson was promoted to corporal December 1, 1954; sergeant May 1, 1959.

Johannson was awarded the Commissioner's Commendation in January 1955, for his excellent work in solving a holdup at the Royal Bank of Canada, and for his assistance to the Vancouver Police Department.

JOHNSON Reg. No. 15917, ex-S/Sgt. Cyrill Arthur Johnson, 65, died March 2, 1997, at Ottawa. He was born April 6, 1931, at Halifax, N.S., where he joined the Force September 26, 1949. Upon completion of training at "N" Division, Johnson was posted to the RCMP Band and subsequently to "A" Division and HQ, retiring on September 25, 1984. He was promoted to corporal May 1, 1962; sergeant June 1, 1969; staff sergeant June 1, 1974.
