UNLESS STRIKES CEASE 20,000 WILL BE LOCKED OUT

Halifax, N. S., July 2.—Capt. S. R. Chicago Building Material Interests Are Tired of Long Drawn Out Struggles Between Contractors and Their Men.

[Canadlan Press.]

Chicago, Ill., July 2.—The building material interests threaten to lock out their 20,000 employees within ten days, if before that time the building trades unions do not settle the jurisdictional strikes which resulted two weeks ago in the lockout of 40,000 men by the contractors. Constructional work on improvements valued at \$30,000,000 has been tied up

"Conditions in the building industry

strikes upon buildings, principally because of jurisdictional disputes between labor unions," reads the resolution adopted last night by the material men. 'These disputes have caused innumerable and almost continuous strikes upon the building interests in general, thereby causing serious financial loss to builders, employers, owners and ourselves."
