

# Chief Will Introduce Fire Drill :: Church Union Hearings Are Again Delayed

## OTHER CITIES HAVE FIRE DRILL

Chief Aitken Will Start Training Here, Protests Council Interference.

City firemen will be required to take pompier fire drill and physical exercises, according to plans which Chief John Aitken entertains, and which are supported by the customs in other departments throughout the province.

Fire chiefs, writing from Brantford, Hamilton, Toronto, Windsor and Ottawa, endorse regular drill for the firemen. London's department had one of the best-trained corps of men in the country before the war. Led by the sturdy chief, they exercised regularly, and were ready and fit for any emergency.

However, regular drill has been allowed to lapse, and the chief is amongst those anxious to see it adopted again. He says that interference from the council has prevented regular exercise.

"There's nothing finer than good exercise and ladder drill for the firemen," declares Chief Aitken. "It keeps them fit and trained. The pompier ladders may be needed on some of London's buildings in a fire. You can never tell when you'll need them. Of course, climbing them may look like dangerous work. But fighting fires is a dangerous job at the best of times."

Committee Inquired.

Under the impression that pompier drill had been discarded as too risky, the finance committee of the council had inquired into several Ontario cities.

"We don't take up pompier ladder drill, but certainly would like to have a training tower," writes Chief DeWilde of Windsor. "We take up physical drill every day and sometimes more."

"Pompier drill is included in our drill work," says Chief W. Russell of Toronto. "We have a half-hour physical drill every day and sometimes more."

"This department does not take up pompier drill, as we have no tower suitable for this work," explains Chief W. T. James of Hamilton. "We have a regular drill with apparatus three times a week."

"We do not practice much with our pompier, as we have ladders to reach the highest building we have here," writes Chief Dan Lewis of Brantford. "We have a drill tower here, and when weather will permit we practice twice a week on this. Our men take lessons in first aid."

Ottawa takes pompier ladder and also physical drill regularly.

"As soon as the weather will permit I am going to have the men out practicing," Chief Allen declared today.

**VILLAGES HEAR TALKS IN WAR ON CORN-BORER**

## BUILDING OUTLOOK NOW IMPROVING

Permits for 20 Houses Given in Past Two Weeks—City Program Lightens.

Impetus given building contracts this month provides a fair outlook for construction work this year and already cuts are being made in the ranks of the unemployed. Erection of some 20 new houses has been authorized during the past two weeks and with considerable excavation to be started immediately an improvement in employment conditions is expected.

The city of London has employed three times as many workmen on outside jobs this winter as in any previous winter. The pay checks last summer went up as high as 500 men in two weeks. This winter they have been as high as 450 men. The city has not been shirking its duty to the jobless, authorities state, but there will be a slight let-up in city work for some time now.

**Winter a Long One.**

The 1924-25 winter has been longer and steadier than usual but work has gone on regularly. The fog ends of a heavy local improvement program are now being finished. Some new work has been authorized, including a Maitland street sewer.

No pavement, sidewalk or gutter work can be started for at least another month. However, a fair season in city construction work is looked for.

## PING CHAMPS WAGE BIG PONG BATTLE

Fight For Supremacy in Annual Tournament in Y.M.C.A. Lobby.

All through the night the battle raged, and through most of the morning and afternoon, too. For a week the Y. M. C. A. lobby has been the scene of one skirmish after another, as the supermen of the ping-pong world have fought for their very existence in the annual tournament, which will come to a close this week.

The "Y" lobby has taken on the appearance of a pugilistic training camp. The fighters sit about swathed in sweaters. The trainers keep a watchful eye on all those who enter or leave the building. The referees are becoming cross-eyed trying to watch two players at once and still keep the ball in the line of vision. Yesterday afternoon and night crowds surged around the players as they battled for ping-pong supremacy. The shield which will grace the den of the winner is uppermost in the minds of the ping artists. It goes down on to desperate right-hand swings and left-hand cuts.

**Seats at Premium.**

Seats were at a premium at the games yesterday afternoon, though few used them. Fast playing, hour after hour, kept the spectators on their feet. For a while the excitement was so great that it looked as if George Day would have to be sworn in as special constable to keep order.

In one set, Lisle Rooke, making a smashing stroke across the board, slipped and turned his ankle. First aid was rendered. In ten minutes he came back strong and defeated his opponent in a smashing victory.

For two hours the cries of "well tried, sir" and "well played, sir" filled the lobby. These came from the gentlemen's corner near the grate fire. From the other side, where the uninitiated park, came "O what a referee," "take him out," "you're all wet," and other savage utterances of softball.

**New Discoveries.**

If the tournament has done nothing else, it has brought a realization of the players to the value of chocolate while training for strenuous battles. Allan Devenney, busy at the counter, issued rations of chocolate of high caloric value to the near champions as they prepared for the worst.

Development in London's Residential and Business Districts Reflected in Report.

**NEW DIRECTORY**

Total of 14,500 Subscribers Is Reached—Many Numbers Changed.

London's steady growth in both residential and down town districts within the past year is reflected in the new Bell Telephone Company's directory, issued this week. The latest edition contains the names of more than 500 additional telephone subscribers in London alone during the past six months.

The new lines have been installed mostly in London homes, but a considerable number has also been set up in business offices and buildings in the central districts of the city.

London now has more than 14,500 telephone subscribers, an amount, according to company officials, which will make installation of a new exchange imperative in the very near future.

The new directory will be mailed to local subscribers probably on Friday. It has a circulation of about 25,000, covering London, St. Thomas and other Western Ontario points.

Many changes in telephone numbers have been made during the past six months, according to Fred A. Power of the contract department. The new numbers and lines, about 400 in all, will be put into operation with delivery of the new semi-annual directory. For this reason patrons are requested by the company to refer to the new edition when calling unfamiliar numbers.

**FOREIGN CAR TANGLE NOW NEARS SOLUTION**

Addition of Rolling Stock to C. N. R. Relieves Trouble of Long Standing.

With the addition of considerable rolling stock to the Canadian National Railway lines, the business may now be carried on independent of the use of foreign cars.

The "foreign car tangle" has been the bugbear of American roads for years. The solution is now seen. The roads have more equipment and the cars are being returned almost as quickly as they are unloaded on foreign soil.

C. F. Forrester, divisional superintendent of the C. N. R. here, said today that the business of returning cars to the United States is carried out with efficiency and despatch. Special efforts are being made to keep up a movement of American cars back to their own districts.

It is difficult to prevent the tangle. The American roads ship coal from Pennsylvania, lumber from Georgia and fruit from California into Canada, and the problem is to get the cars back without running long strings of empties, which is a profitless business, said the superintendent.

Just now, Canadian cars are carrying a lot of paper from Thorold to points in Illinois and New York. These will be returned filled with American products for Canada.

**GRAHAM WOULD REFUSE ANY FAVORS IN PRISON**

Has Regular Fare of Porridge, Bread and Tea For His Breakfast.

Lieut.-Col. C. M. R. Graham, sentenced to from six months to two years in the Ontario reformatory yesterday by Magistrate Graydon for the theft of some \$3,000 first division court funds, does not want nor will accept any favors at the hands of jail officials.

"I'm not going to ask for any special privileges, nor do I expect any," the colonel is reported to have told the jail authorities. "Whatever the rest of the men are having for their evening meal will be good enough for me."

On his arrival at the jail yesterday, Col. Graham was greeted by one of the turnkeys, who served under him as a private in the 142nd battalion. Col. Graham is still wearing civilian clothes, but will don the jail uniform at black and gray unless removed to Guelph in a few days.

## EFFORTS RENEWED IN CHURCH ISSUE

Further Postponement Until Tuesday Made to Permit Conferences.

Toronto, March 18.—A further postponement of the church union bill discussion was made by the private bills committee this morning. It stands until 10 a.m. Tuesday.

Mr. Nickle said that after the committee had adjourned yesterday conferences were held until night and demands had been reduced to the irreducible minimum. But while the conferences had ended in failure hope had again come with the morning. He had conferred with both sides, each side hesitating to speak.

He asked questions in regard to an adjournment until Tuesday in order that further conferences may be held.

D. L. McCarthy, K.C., representing the non-concurrensts, said that as long as there was any possibility of coming to a settlement his instructions were to consider any arrangement that might be presented. There was a sincere wish for settlement, Mr. Mason, K.C., for the unionists, concurred in Mr. McCarthy's remarks. It was obvious that there were real difficulties in the way, and also that a determined effort was being made by both sides to overcome them. The difficulty, said Mr. Mason, was the "inherent difficulty created by the subject matter."

A. H. Rankin, M.L.A., who sponsored the bill, urged that time was very short and something definite must be arrived at by next Tuesday. Alex. Lewis, M.L.A., declared that all present were anxious for a settlement. There was a persistent rumor that matters not pertaining to the Ontario situation were the cause of inability to arrive at an agreement. He was strongly of the opinion that so far as Ontario is concerned the matter should be settled as an Ontario situation.

W. S. Haney, M.L.A., then moved the following resolution, seconded by Mr. Lewis:

"That with sincere regret the private bills committee had learned this morning of the failure of the proponents and opponents of church union to arrive at an amicable adjustment in relation to the division of church properties and moreover, if humanly possible to spare people of this province a recurrence of the bitterness that characterized the controversy of last year, this committee are still of the opinion that even greater efforts should be made to arrive at a solution of this vexed question."

The committee room was crowded with representatives of both sides and after the adjournment groups gathered in the corridors. There seemed to be a feeling that a settlement of some kind should be reached before next Tuesday. The official representatives of both sides then went into private conference with Hon. Mr. Nickle in attendance.
