Hon. Maurice Sauvé (Minister of Forestry): 1. Under the forest access section of the federal-provincial forestry agreement, the province of Quebec has requested federal financial participation in the construction of a forest access road between Belleterre, Témiscamingue county and Le Domaine, Pontiac county.

2. (a) Under the terms of the federal-provincial forestry agreement, the federal government will pay one half the cost of construction or improvement of any road or trail intended primarily for the protection and management of forest lands or the transportation of forest products removed therefrom.

(b) The province of Quebec has requested for the fiscal year 1964-65, that the federal government pay one half of an estimated expenditure of \$100,000 for the construction of the first 15 miles of the road extending from Belleterre eastward to Lac à la Truite.

3. The federal government has accepted the proposal as presented by the province of Quebec.

1. For the calendar years 1959-1963 inclusive, McMaster have received the sums of \$8,000, \$8,000, \$8,524, \$14,018 and \$17,465 for a total of \$56,007.

2. Contracts for the conduct of research.

In so far as the Atomic Energy Control Board is concerned: 1. 1959-60, \$65,000; 1960-61, \$100,000; 1961-62, \$140,000; 1962-63, \$140,-000; 1963-64, \$170,000.

2. All funds in each of the five years used for the purpose of research in the McMaster University reactor.

2. These funds were made available for the support of four research projects and for the employment of teaching personnel for the postgraduate training course in psychology at the department of psychology.

The research involved the following studies. 1. Analysis of the social organization of mental hospital wards.

2. The effect of training schedules on rigidity as manifested by normal and feebleminded children to determine the effect of rigidity on discrimination reversal learning.

3. The effect of originality training on the learning of mentally retarded children; and

4. Clinical studies of circulation in cardiopathic patients using the inhalation radiocardiographic technique.
