EXTERNAL AFFAIRS

OTTAWA—COMPENSATION FOR DAMAGE TO RUSSIAN EMBASSY

On the orders of the day:

Mr. Terence Nugent (Edmonton-Strathcona): I should like to direct a question to the Secretary of State for External Affairs. Did he receive a request from the Russian ambassador for special police protection for their embassy last night? If so, can he tell us why enough police protection was not provided to prevent the shameful lawlessness which occurred there?

Hon. Paul Martin (Secretary of State for External Affairs): The Department of External Affairs has been in consultation with the Ottawa police who are, of course, the authorities directly responsible for the maintenance of law and order. The measures taken by the police were inadequate in the circumstances, in my judgment, and I regret that this was so. I took note of the Soviet representations, including those made by the ambassador, and directed that all desirable means of satisfying them be pursued. We were assured by the police that everything possible would be done within the law to avoid untoward incidents and to ensure that free access to the embassy was maintained, just as we would insist on free access to our embassy in Moscow or any other capital.

The police authorities pointed out, however, that there were clear statutory limitations to action which might be taken to deal with such demonstrations. The Soviet ambassador was so informed. Citizens in Canada, of course, are free to express their opinions in a lawful way. It is the responsibility of the police to deal with those who break the law.

I have directed that the necessary measures be initiated to compensate the Soviet government and to assist the Soviet embassy to clean up and repair the damage done.
