## ROYAL CANADIAN MOUNTED POLICE

### PURPOSE OF INQUIRY INTO DROPPING OF LITERATURE PROTESTING AGAINST BILL C-176 FROM AIRPLANE

**Mr. Jack McIntosh (Swift Current-Maple Creek):** Mr. Speaker, on Thursday last I directed a question to the Minister of Justice in the absence of the Solicitor General. I see the Solicitor General in the House today. I wonder whether he could answer the question which was as follows:

What was the reason or purpose of the RCMP inquiry into the procedure used by western ranchers and farmers of dropping literature from an airplane protesting against Bill C-176 at several rural points in southeastern Alberta?

I hope the minister received that question from the acting minister.

**Hon. Jean-Pierre Goyer (Solicitor General):** Yes, Mr. Speaker, and I thank the hon. member, but I think that the question should be put to the Attorney General of the province involved.
