## AGRICULTURE

EFFECT OF LONGSHOREMEN'S STRIKE ON SUPPLY OF FEED GRAIN—GOVERNMENT ACTION

ALLEGED AGREEMENT CANADA WOULD NOT RETALIATE FOR BOARDING OF "GREENPEACE III" BY FRENCH AUTHORITIES

Mr. Stuart Leggatt (New Westminster): Mr. Speaker, my question is directed to the Secretary of State for External Affairs. A report this morning indicated that the French admiral in charge of the operations of a nuclear test in the Pacific was given the assurance that in the event of the boarding of the Canadian vessel Greenpeace III there would be no retaliation by Canadian authorities. Would the minister advise the House whether he is conducting an inquiry into this very serious allegation of connivance?

Hon. Allan J. MacEachen (Secretary of State for External Affairs): Mr. Speaker, I heard the same report and I have asked for information on this point.

Mr. Leggatt: Is the minister in a position, as a result of this inquiry, to advise this House that Canadian authorities have not in any way conspired or connived in this act of piracy by the French government?

Mr. MacEachen: I will be happy to give the hon. member the information once I receive it and will make any statements that are justified in the circumstances.
