### CANADA—UNITED KINGDOM TALKS ON SOCIAL SECURITY

## Question No. 1,682—Mr. Munro (Esquimalt-Saanich):

- 1. Did talks between the British and Canadian authorities take place last April on a reciprocal agreement between the two countries on social security and, if so, what progress can be reported on these talks?
- 2. (a) In what areas, e.g. pension payments, medical benefits or whatever, is there disagreement still to be resolved (b) for what reason are these talks so protracted?
- 3. Is there a date fixed on which talks are to be resumed and, if so, what is that date?
- 4. Is the scheme for Canada to assume payments in Canada for British pensioners and Britain to assume payments in Britain for Canadian pensioners, or will each country continue to look after its own migrant pensioners?

Mr. Herb Breau (Parliamentary Secretary to Secretary of State for External Affairs): 1. Late in March, 1974, the deputy minister of National Welfare had conversations with British officials in London covering the British [Mr. Sharp.]

Green Paper on tax credits as well as social security relationships and developments in the two countries. While better understanding was achieved as to the internal workings of the two systems, it also became clear that the current state of legislation in the two countries precludes the reaching of a reciprocal agreement at this time.

- 2. (a) and (b). At this stage, the problem in reaching a bilateral reciprocal agreement does not lie with different types of benefits but rather the different provisions of the legislation in the two countries.
  - 3. No date has been fixed for further conversations.
- 4. As noted in (2) above, the different provisions of legislation in the two countries will require examination of a variety of possibilities.

To do so could seriously undermine the department's statistical system by casting doubt on the department's credibility in its assurances to fishermen and processors that all information secured from them is maintained in the strictest of confidence.
