DISTRICT AND GENERAL.

News of Local Interest Condensed From Our Exchanges.

The Strathroy newspapers will not be issued this week.

Messrs. Downswell & Smith, builders and contractors, of Dutton, have made an assignment.

Stephen Lumley at Sarnia was sentenced to serve three years in penitentiary for perjury.

The question of municipal ownership of the electric light plant is being discussed in Watford.

A hockey club has been organized at Alvinston. Dr. Martyn is president and A. E. Ketch secretary.

John McCallum, a former resident of West Lorne, died recently at Marlette, Mich., in his sixtieth year.

A company will start in Brantford early in the new year to make and retail bread at four cents a loaf. The present price is five cents.

Chatham model school had 35 pupils last term, and 29 of them have been engaged as teachers at from \$350 to \$450 a year. There is a strong demand for teachers.

A man with a conscience went to the customs officers at Sarnia the other day to pay duty on a gold watch and chain which he smuggled into Canada about twenty-five years ago. He was allowed to pay.

A Watford man brought home a sample of the potatoes grown at Davidson, Saskatchewan. Two of them weighed within a couple of ounces of five pounds and would make a square meal for a hired man.

Dr. Sheard, Toronto health officer, says there is every fear of a smallpox epidemic in the province, and he advocates general vaccination in Ontario, and a house-to-house vaccination in all of the cities as a preventive.

The county board of examiners announces that every student who wrote at the London and Strathroy Model School exams recently, was successful. This is a particularly creditable showing. The certificates which have been granted the students are third class, and are valid for three years.

While ploughing on his farm near Port Talbot, Thos. Lunn unearthed a human skeleton in a fairly good state of preservation. The bones are supposed to be those of an Indian woman, and have lain in the lonely grave for probably scores of years. In the same field, which has been ploughed for a dozen years, have been found Indian relics.

At a special meeting of the Tilbury East council, called to consider the shortage of W. F. Robertson, ex-treasurer, a statement was effected. The sum of \$2,800 was realized from the assignment of Mr. Robertson. In addition to this the bondsmen have paid \$1,400, making a total of \$4,200, which was accepted by the township in lieu of the alleged defalcation of \$7,000.

There are not many hoboes or transients of the vicious type in Ontario at the present time. The fact is that the campaign of the past year or two, in which the magistrates of the province assisted by imposing long terms on those taken into custody, has had the effect of practically exterminating the province of the Wandering Williams and Plodding Peters. On the freight trains the hoboes are scarcely ever seen.

At St. Catharines, on Thursday, Mayor Sweet informed a meeting of local shareholders of the York County Loan that he had been assured that day by telephone by Mr. Cross, the accountant appointed by the Government to investigate, that holders of terminating shares would in all probability receive 100 cents on the dollar. Until the terminating shareholders are paid, holders of permanent shares will not get a dollar.

Alexander Willis, of Rodney, has entered suit against Mary Cole and William Cole, her husband, claiming unstated damages for slander. The action arises out of the alleged statements made by the defendants charging Willis with the theft of a set of harness about the time of the recent murder. The plaintiff was found not guilty of the crime, and the other parties to the suit were prominent witnesses at the trial.

Watford Board of Trade has received a communication from a Toronto manufacturing firm, who manufacture worsted and cashmere knit goods, sweaters, jerseys, toques, underwear, etc. The firm is prepared to install a plant requiring about 40 hands to operate it, mostly females, and additional machines later on if hands are available. Knitters are paid up to \$7 weekly, finishers \$1 less, hand sewers average the same. The inducements the firm expects are exemption from taxes, building at low rent, and a reasonable bonus.

A week or two ago in Dunwich, it is related, a boy named Robert Dell returning from school found the body of an infant on the fifth concession road. He told his father when he got home, and both returned to the place where the child lay. The elder Dell removed the body to one side of the thoroughfare, and sent his son to advise the coroner, Dr. Ling. The doctor is alleged to have ordered the dead child to be left where it was found. Mr. Dell did so, and covered it with a box. In the morning the coroner and Mr. Dell drove out to make further investigations, but, on raising the box, it was discovered that the child's body had been removed.

MUNICIPAL NOMINATIONS.

VILLAGE OF GLENCOE.

Reeve J. N. Currie retires and Councillor Neil Graham is elected by acclamation in his stead. Mr. Lewis Suiter succeeds Mr. Graham as councillor, and Councillors W. D. Moss, P. D. Keith and Hiram Lumley are re-elected—all by acclamation. For school trustees, Dr. Walker, W. J. Small and Charles Currie were also elected by acclamation.

The nomination meeting was held from 7.30 to 8.30 in the evening, and was then adjourned for discussion of affairs until Tuesday evening. Nominations were made as follows— For Reeve—Neil Graham, by W. D. Moss and Levi Annett.

For Councillors—P. D. Keith, by W. D. Moss and D. McLachlan; Lewis Suiter, by D. McLachlan and J. Watson Young; W. D. Moss, by J. H. French; Charles Currie, by Mark Walker and W. D. Moss; Dr. Walker, by John Hayter and Geo. Lethbridge; W. J. Small, by J. H. Hicks and W. D. Moss. Messrs. T. K. Pool, J. H. Neve and Jas. Gilbert withdrew.

TOWNSHIP OF MOSA.

Reeve George Innes retires, and Mr. James Douglas, a former councillor, is elected by acclamation in his stead. A poll will be taken for councillors, the candidates being Dugald C. Gillies, Thomas W. Glasgow, George A. Seccord, John Stinson and William H. Watterworth. The first four named are councillors this year. Those who were nominated for reeve and withdrew their names are George Innes, Wm. Webster, Mark Walker, Thomas Simpson, John S. Gibb and John L. Mitchell.

TOWNSHIP OF EKFRID.

Reeve L. L. McTaggart is a candidate for re-election and will be opposed by Councillor D. Decew. Councillors Christopher Dobie, Warren M. Lockwood and Chas. M. Macfie were re-elected and John McAlpine elected, all by acclamation, as the councillors for 1906.

For Reeve—Wm. Tolmie, Farquhar McCallum. For Councillors—Ogle Stinson, Jas. McLean, Andrew Wiley, Neil Currie, Barnum House. All are new candidates except Messrs. Currie and McLean, present councillors. Messrs. Dan Hyndman and George Robinson were also nominated for councillors but withdrew.

TOWNSHIP OF DUNWICH.

James E. Graham, reeve, and Geo. O'Malley, councillor, retired, as both are going west next spring. The following were nominated: For Reeve—John Gow and Alex. G. Duncanson. For Councillors—Alex. McLachlan, Dugald Blue, Wm. W. Gow, Wm. H. McAlister, John Dromgold, Peter Crawford, James C. Brown, George Braddon. John R. Gow declined the nomination for reeve, and Alex. Duncanson was declared elected by acclamation. The above-named nominees for councillors will go to the polls, with the exception of John Dromgold.

The appointment of the new county constables to take the place of those recently dismissed was made by Judge Macbeth at the general sessions last week.

Six men were appointed to fill the places. They are—Ed. Guest, The Grove; R. S. Nichol, Hubrey; J. D. McColl, London; Albert Carrothers, Dorchester; Wm. Wilson, Strathroy; and H. J. Heath, Hyde Park.

The first four were recommended by the county council. Wilson was recommended by the mayor and police magistrate of Strathroy, and Heath was recommended by the reeve of the township.

Other applicants were Chas. Beckett, of Strathroy, Duncan M. Stewart, of Glencoe; Jas. Bennett, of London; A. McLeish, of Springbank, and Benjamin Blackstock, Iderton, all recommended by the county council.
