Mr. Mabee says that out of 49 Conservative candidates, asked as to their choice for the Opposition leadership, only 7 wanted Mr. Whitney as first choice. The other votes were as follows: W. F. Maclean, 19; Dr. Nesbitt, of Toronto, 18; J. J. Foy, 5. It would seem from this that Mr. Whitney represents not only a minority in the House, but also only a minority in his own party.

The German Press is viewing somewhat suspiciously the Pan-American Congress. It admonishes the delegates from the Central and South American States to look out for the wiles of the United States representation. Germany's apparent cynicism is not altogether without good grounds. Her trade with the Central and South American States is somewhat extensive, and no doubt more amicable relations between these states and the United States would greatly enhance the trade of the latter at Germany's expense.

The Hon. David Mills has been spending a few days at Queen's University, where he has given some lectures on Law and Constitutional History. The Minister of Justice is a busy man, but we are glad that he finds time to write articles discussing Imperial Questions, and also that he was able to show his sympathy with the work of Queen's at this particular juncture. The lectures have been highly appreciated, and it is hoped that Mr. Mills will be able again to visit Kingston, to meet with professors and students.

A Southern newspaper, apropos of the subject of President Roosevelt's dining and wining Booker T. Washington, the negro reformer, states that "a dinner given in the home and privacy of his family means that the guest or his son may woo and win the host's daughter." The same journal goes on to state that there is but one more step to miscegnation. What can be more absurd than such a contention? What obligation can the mere entertainment to dinner place either the host or the guest under than merely the bonds of friendship! If such hospitality could possibly point to a mixture of races, what can be said of the fact that eastern princes have been regaled at the festal board of British royalty?

Mr. Jerome, who is now 42 years old, came upon the bench under the reform administration of Mayor Strong, and of late he has been conspicuous in efforts to hunt down Tammany-protected vice in the city. In this campaign he is the most aggressive and incisive speaker on either side, and seems to have the capacity to make an indefinite number of speeches nightly. There is a great eagerness among all classes to hear him, and his utterances are as serious as they are fearless. He recently lectured the Woman's Municipal League for presuming to go down to the tenement house women below Fourteenth street and instruct them in politics. The New Ameer.

The death of Abdurrahman Khan. who for over twenty years held the position of ameer or ruler of Afghanistan, has given occasion for the accession of his son, Habibullah. The correspondent of the London Times writes, concerning the old and the new ameer, as follows: "The late ameer was more feared than loved by the mass of his subjects, who probably welcome the milder rule of Habibullah, as the latter is a man of gentle disposition, though of marked administrative capacity also. He is not a great soldier, but the army respects him." In justice to the late ameer it may be stated that during his twenty years of office he did more in the matter of welding together the discordant elements in Afghan society than had any of his predecessors. The new ameer is now 38 years of age, and is quite conversant with the routine of administration. He has not only governed time as his father's representative in the seat of government.

He has sat long in the seat of judgment, and he has known how to dispense justice as Orientals expect to see it dispensed by a king. His courage is free from the stain of ferocious cruelty, which was so conspicuous in his father, but there is no reason to suppose him incapable of the prompt severity which the government of a race so lawless as the Afghans oftentimes demands at the hands of their master. The barbarities practiced by the late ameer struck terror into the hearts of his enemies, but some good judges believe that they were not calculated to lessen the difficulties of his successor. If, on the other hand, they do not provoke disturbances for the sake of vengeance, they cannot but act as a foil to the milder sway expected of Habibullah. As the governors of the provinces and the military officers stationed at a distance from Cabul are all faithful followers of the late ameer, it is believed that they will exert themselves to secure the great aim of his declining years by upholding the succession as he arranged it."

Peculiar Finding of the Jury in

Matter Will Have to Go to Court of Appeal-The Judge's Charge.

Toronto, Nov. 2 .- Practically the verdict of the jury in the Rice case is that a certain conclusion that Rice had killed Constable Boyd could not be reached, but that the existence of a plot to escape was planned, and that Rice, by taking any part in it, rendered himself responsible for the consequences. The result of the finding will be that the case will come before the court of appeal, and that body will decide on the fate of the prisoner. He is now convicted of murder, but not sentenced, being held for a reserved case under conviction of being an accom-

The verdict was returned after the jury was out for three hours and a quarter. At 3:40 o'clock the foreman asked for definite instructions as to the judge's remarks on the second branch of the case. 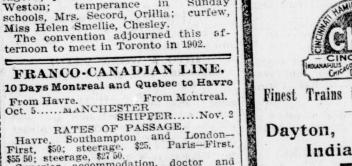
