Attendance of prime minister at coronation and imperial conference an indication of short session; abdication of King Edward VIII, 25; New Year's message of King George VI; statute dealing with succession to the throne, 26; action of executive in making known the views of Canada on question of change of sovereigns; seriousness of international situation; failure of League of Nations, 27; incorporation of covenant dealing with League of Nations in Treaty of Versailles at instance of United States, and subsequent rejection of treaty and covenant by United States Senate; improvement in Canada's trade since 1934, 28; general improvement in international trade and in world conditions; effect of trade treaties with Russia, Germany and United States; increase in revenues due to increase from six to eight per cent in sales tax; increased rate on corporation income tax, 29; effect of change in powers of wheat board by order in council on prices obtained by farmers for wheat, 30; world's net exports of wheat; drop in Argentine and United States wheat exports; depriving our farmers of benefits of world market
