2. What alterations or new construction work have been undertaken or authorized on any of the above

properties since purchase thereof?

3. What expenditures have been made to date on each of the said properties for (a) equipment; (b) administration and operation; (c) total expenditures, to date?

4. Have any of the said properties been leased since purchase? If so, to whom, and on what terms?

Mr. Bradley: Mr. Speaker, I understand the hon. member for Cumberland (Mr. Black) proposes to make an amendment to this question. If he would do that now, perhaps the answer could be obtained more quickly.

Mr. Speaker: Dropped?

CANADIAN NATIONAL RAILWAYS

PROVISION FOR REFUNDING OF FINANCIAL OBLIGATIONS AND ISSUE OF SUBSTITUTED SECURITIES

Hon. Douglas Abbott (Minister of Finance) moved that the house go into committee at the next sitting to consider the following resolution:

That it is expedient to present a measure to provide for the refunding of matured, maturing and callable financial obligations of the Canadian National Railways and for the issue of securities guaranteed by the Dominion of Canada in respect of such refunding to an aggregate principal amount not exceeding \$200,000,000.

He said: His Excellency the Governor General, having been made acquainted with the subject matter of this resolution, recommends it to the consideration of the house.

Mr. Knowles: —and has turned the great seal over to Mr. Justice Kerwin, appointing him as Administrator, should not this approval have been given in the name of His Excellency the Administrator rather than in the name of His Excellency the Governor General?

Mr. Abbott: Mr. Speaker, I think this measure was submitted some time ago. But if it will make my hon. friend any happier, I shall be very glad to have *Hansard* substitute the words "His Excellency the Administrator" for the words "His Excellency the Governor General".

Mr. Knowles: May I ask which of these gentlemen was consulted?

An hon. Member: Sit down.
