FOREIGN EXCHANGE

CANADA-UNITED STATES—REFERENCE TO REMARKS OF MR. HOWE IN DEBATE ON JUNE 5

QUESTION AS TO PROCLAMATION

METEOROLOGY

APPROVAL OF CONVENTION OF WORLD METEOR-OLOGICAL ORGANIZATION SIGNED AT WASHING-TON OCTOBER 11, 1947

The house resumed, from Monday, June 5, consideration of the motion of Mr. Chevrier:

That it is expedient that the houses of parliament do approve the convention of the world meteorological organization signed at Washington on October 11, 1947, and tabled on February 14, 1949, and that this house do approve the same.

Mr. Howard C. Green (Vancouver-Quadra): Mr. Speaker, having now had an opportunity to review the terms of this convention, I am going to suggest to the Minister of Transport (Mr. Chevrier) that he have it considered by the standing committee on external affairs. This committee is now sitting, and there would be very little delay. I believe the committee has never had an opportunity to consider this convention. It would be possible to call before the committee not only officials of the Department of External Affairs, but also the chief meteorological officer of the Department of Transport, and other witnesses if necessary.
