**Right Hon. P. E. Trudeau (Prime Minister):** Well, Mr. Speaker, we do not intend at all to link both questions. I think this rumour would offend the government of Quebec which surely would not be corruptible enough to sell some rights in exchange for an amount of money.

### SUGGESTED ESTABLISHMENT OF SCHOOL MILK PROGRAM— GOVERNMENT POSITION
