CONDEMNATION OF U.S.S.R. TRIAL AND SENTENCE OF YURI ORLOV—MOTION UNDER S.O. 43

Mr. Joe Clark (Leader of the Opposition): Mr. Speaker, I have a motion which I trust will receive the unanimous agreement of the House. I ask leave, on a matter of urgent and pressing necessity, to move a motion under Standing Order 43 which concerns the case of Yuri Orlov, the Russian physicist who has been tried and convicted in the Soviet Union for the so-called crime of forming a group to monitor Russia's human rights performance against the pledges made in the Helsinki agreement. I therefore move, seconded by the Deputy Prime Minister (Mr. MacEachen):

That this House deplores the trial and extremely severe sentence given Yuri Orlov by the Soviet Union for his activities with the Moscow-Helsinki group, activities which in Canada would be perfectly acceptable.

Mr. Speaker: Order, please. Presentation of such a motion for debate, pursuant to Standing Order 43, can be done only with the unanimous consent of the House. Is there unanimous consent?

BEEF STABILIZATION PAYMENT—MOTION UNDER S.O. 43

We were advised some months ago that a stabilization payment would be made to beef producers who marketed cattle for slaughter in the first quarter of 1977, the producers realizing that the Minister of Agriculture probably intended that this payment would be sent

That the Minister of Agriculture immediately announce the amount of the payment to be made and make provisions to get this payment into the producers' hands as soon as possible, because we are now well past the first quarter of 1978.

GRANT TO FACTORY THEATRE LAB OF TORONTO—MOTION UNDER S.O. 43
