## FINANCE

SASKATCHEWAN IMMEDIATE EMPLOYMENT STIMULATION FUND—ROLE OF SENATOR ARGUE

Mr. Lorne Nystrom (Yorkton-Melville): Mr. Speaker, my question is directed to the Right Hon. Prime Minister in the absence of the Minister of Finance and of the Minister of Employment and Immigration. Yesterday I raised the question of the Immediate Employment Stimulation Program in Saskatchewan, the fact that Senator Hazen Argue is sitting on a \$4 million fund, and that he and his office are the sole access to that fund. Public servants are not involved in screening the cases or applications or in analysing the applications. Federal MPs in this Party and in the Conservative Party were not notified about the fund. The fund is for capital works.

In light of all that information, can the Prime Minister tell the House what right the Government has to give the Senator \$4 million to spend in an unconditional way in the Province of Saskatchewan without the help of the Public Service, or without notifying Members of Parliament? If he disagrees with that, would he be prepared to table documents in the House proving that departmental officials were involved in all Saskatchewan decisions prior to a decision being made by Senator Hazen Argue?

**Right Hon. P. E. Trudeau (Prime Minister):** Mr. Speaker, I have many reservations about the premises of the question. I will take careful notice of them, investigate them, and have the Minister advised of the concern of the Hon. Member.
