#### PROSPECTS FOR FORT ERIE HELICOPTER PROJECT

Mr. Girve Fretz (Erie): Mr. Speaker, my question is directed to the Minister of Industry, Trade and Commerce who is involved in a Cabinet meeting behind the curtain. I understand that the Minister will soon be announcing a deal involving the federal and provincial Governments, Fleet Industries of Fort Erie, and a German helicopter firm.

As the Minister knows, this year the Niagara region has been twice cited as the unemployment capital of the country. First, is it true that Fleet will get the helicopter deal and, second, if it is true, when will the Minister make the announcement?

Hon. I would request that the Hon. Member refrain from discussing this issue until such time that we finalize negotiations with the company.

Member is serious about these jobs, I think, as I have suggested to him privately and now publicly, that the least said publicly during negotiations usually leads to more productive results.

# SERVICES FOR FEMALE VICTIMS OF VIOLENCE
