Of the *House of Assembly* of the Province of *Nova-Scotia*, begun and held at *Halifax*, on Wednesday the 20th Day of March, in the Thirty third Year of the Reign, of our Sovereign Lord GEORGE the Third of *Great-Britain, France, and Ireland*, King, Defender of the Faith, &c.

HIS Excellency the Lieutenant Governor, having, by his two several Proclamations (hereunto annexed) dated the 22d *January*, and 19th *February* last, dissolved the last *General Assembly*, and called a new one, and appointed the same to meet and sit at *Halifax* this Day, being the Twentieth Day of *March*, 1793; the following are the Names of the Members returned by the Sheriffs, for the several Counties and Towns within this Province, to represent the same, in the said *General-Assembly*, summoned to meet as before mentioned, viz.
