# THE WEEK'S DOINGS AT THE CAPITAL

Important Matters Brought Before the House.

Bourassa's Proposals Fell Flat-Sir Wilfrid Laurier at His Best-Salient Points of the Budget-Biggest Surplus in the Dominion's History.

Ottawa, March 16.-The week just passed has been the most interesting of the present session thus far, the Lord Kitchener was credited with of-fering terms which Gen. Botha was events of more than ordinary moevents of more than ordinary moment-the presentation of the budget, the discussion on Mr. Bourassa's "stop-the-war" resolution in the commons, and the debate on Sir Mackenzie Bowell's motion to appoint a committee to investigate the Cook charges in the Senate.

First in point of time came the Bourassa resolution, on Tuesday afternoon. In itself the motion did not merit the amount of attention it re ceived, for the position of Canada in this question has been unmistakably and emphatically recorded, and the declaration of sympathy with and support of the imperial government in its policy in South Africa, has been stronger and more unanimous at each repetition. Public interest, however, was very manifest on the present occasion, and the galleries were crowded. the hundreds present being amply rewarded by the magnificent speech of the premier-declared by one of the leading Tory papers to be "one of the best, if not the best," he ever delivered-and by the sturdy patriotism of the half dozen others who followed him on either side of the house.

BOURASSA'S PROPOSALS FELL

Mr. Bourassa presented three propositions in his resolution: (1) That there was no need to send further contingents from Canada to South Africa, (2) that enlisting for the South African constabulary should not be allowed in Canada, and (3) that the imperial government should forthwith conclude peace, giving the conquered republics their independence again. He supported these contentions with a two hours' speech, which, however did not once arouse the faintest indication of approval in the house THE PREMIER AT HIS BEST.

The rising of the premier to reply

was the signal for a marked change in this respect, and the cheers which greeted him were repeated at frequent intervals during the delivery of his splendid speech. Having disposed of the first proposition agreeing that no more Canadian troops were needed, because the closing up of hostilities could be attended second by the observation, that he knew not on what principle the government could interfere with any loyal Britisher volunteering to serve his King and country if he so desired, the premier proceeded to vindicate the imperial policy by as admirably a complete and concise retrospect of the events which lead to hostilities and had marked their progress, as could well have been presented. Sir Wilfrid carried his audience with him enthusiastically, and the result was a foregone conclusion. But one feature of the incident has not received the attention it merits. If Mr Bourassa had any justification at all for taking up the time of the house with this matter, it was as being representative of the people of Quebec. He claimed to was overwhelmingly indorsed in Quebec last November, took issue upon this very point, as he did before the elections and during the campaign. The unwavering and increased supmier received from Quebec is the best which he undeniably possesses.

THE BUDGET. It used to be said of William Ewart Gladstone that he was one of the very few men who could make figures interesting, and that great financier's budget speeches were accounted among the events of the parliamentary session. In the same way the annual budget speech of Canada's chancellor of the exchequer has come to be looked forward to, for with perhaps the single exception of their first budget, the details of which were a legacy from their Tory predecessors, rathe than of their own producing, the country's balance sheet has been invariably satisfactory, and grows more so every year.
