

## MR. BRAND ON A PLEASURE JAUNT

Owens of the Vanquished Spruce IV at the Queen's-Leave for England

Next Week

Mr. J. Arthur Brand, the plucky

challenger for the Seaynaka-Corinthian

Yacht Club's Cup, arrived in the

city yesterday on a pleasure jaunt

and is staying at the Queen's-Leave

Hotel. He is the typical Englishman

and did not care to give an opinion

on either of the recent international

yachting contests.

Of course, the defeat of Spruce IV

by Mr. Field's Ethelwynn was a serious

disappointment, as Mr. Brand was

confident of winning with his fleet

half-rater, which he now wants to

sell. He was totally non-committal

about the Defender-Valkyrie

rivalry, preferring to wait until the

official report of the race's result

appeared in England.

Mr. Brand will meet the members

of the R.C.Y. at the town club house

at 3 o'clock this afternoon and will

leave for the east in the evening to

sail for England next week.

A Split Record in London.

The game between Messrs. Brown

and Betts to decide the tie in which

the September handicap match of the

London Club resulted in a draw, was

played yesterday afternoon, says The

Advertiser. On the former occasion, Mr.

Betts won by a score of 10 to 9, and

the score was even, and necessitating

a re-match to decide the tie.

Saturday's match was played at 3

p.m. on the club's links. In the first

round, Mr. Brown, who was playing a

very steady and careful game, scored

46, a figure which exactly equals the

score of the 18-hole match, which was

held by Mr. Brown. Mr. Brown's

second round, therefore, started with

Mr. Brown 8 strokes to the good, i.e.,

11 strokes ahead in all.

Each hole was closely contested,

and when the 18th hole was reached

the score, in actual strokes, stood

22 to 16 in Mr. Brown's favor. The

winning hole was made by Mr. Brown

in 6 and by Mr. Betts in 3 strokes,

thus tying the score of actual

strokes.

The scores for the second round

were: Mr. Brown, 44; Mr. Betts, 44;

the result being that Mr. Brown won

by his handicap allowance of

four strokes. The match was interesting

as having established several new

records.

The score of 98 made by each player

now forms the record for the London

links (in any match played between

two players of equal handicap), and

the score of 100, which was made by

Mr. Brown in 1894, is now a record.
