No. 1, St. David, county of Levis, and the calling for new tenders in connection with the said rural route; together with copies of all tenders, prices, recommendations, submitted by any contractor who proposed undertaking the work of carrying the mail on the said Rural Route No. 1, St. David.

Also,—Return to an Order of the House of the 22nd February, 1932, for a copy of all correspondence, reports and other documents in connection with the dismissal of postmaster, C. E. Sproule, at Rockglen, Saskatchewan; also a copy of all correspondence, reports and other documents relating to an investigation into charges made against postmaster, C. E. Sproule, at Rockglen, Saskatchewan, his dismissal and the temporary appointment of Mr. Lawrence in his stead.

Also,—Return to an Order of the House of the 7th March, 1932, for a copy or list of all rural mail contracts put up for public tender since March 1, 1931, up to March 1, 1932, in the provinces of Nova Scotia, New Brunswick, and Prince Edward Island, showing amount paid under old tender and also amount paid under new tender in each case.

And also,—Return to an Order of the House of the 22nd February, 1932, for a copy of all letters, telegrams, correspondence and other documents passing between the Postmaster General or any of his officials and any person or persons in the Province of Saskatchewan, since September, 1931, with reference to the appointment of a postmaster for the Post Office at Mitchellton, Saskatchewan.

Mr. Brasset, seconded by Mr. Boulanger, by leave of the House, introduced a Bill, No. 36, An Act to amend the Bankruptcy Act (Locality of a debtor), which was read the first time, and ordered for a second reading at the next sitting of the House.

The Orders of the Day being called;

Mr. Bennett moved,—That the present debate, namely the debate on the proposed motion of Mr. Bennett: That Mr. Speaker do now leave the Chair for the House to resolve itself into Committee of the Whole on the following proposed Resolution:—

That it is expedient to introduce a Bill to amend Chapter 58 of the Statutes of Canada, 1931, striking out the word "March" in Section 8, and substituting the word "May" therefor; and the proposed motion of Mr. Weir (Melfort): "That this question be now put", shall not be further adjourned.

And the question being put on the said motion; it was agreed to, on the following division:—
